CHOISES YOUNG WOMEN'S CO-OP GARDEN RE-DEVELOPMENT

CHOISES Young Women's Co-op garden redevelopment opened to members on 30 March 2019 at the Randwick community residence.

For over 20 years, CHOISES community members have used the carpark for Randwick meetings. A strip of dirt and grass ran down past the car park along the side of the building. With no solid flooring or cover, the side strip was under-utilised space.

With wonderful support from the SHCIF Grant Body, awarding a \$37,866.80 grant, landscaping of the space was soon underway. According to long-standing members of the co-op, the community needed a functional outdoor space, accessible all year round. We designed a community garden, meeting and recreation space, with an emphasis on community engagement and accessibility. We built a permanent wooden pergola, community garden beds, decking, pathway, and did general landscaping and excavation.

After months of hard work, the CHOISES garden was ready to be used by the community. After the opening, members tried out the space and discussed working bees for growing garden produce, such as pumpkin, leafy greens, herbs and tomatoes.

Stone and Lotus Landscaping and Matt Perry Gardens were appointed as the landscape architects, and their plans and vision were available to members to be a part of the decision process during the consultation period.

These new and upgraded facilities are important, and over the past few months CHOISES Young Women's Co-op has begun to use them to host co-op community meetings and use the space as a training and workshop area. Our initial concept was realised in full, with a strong focus on community use of the space.

We are keen to continue nurturing our community by using this new space to recognise and develop the talents, diversity and multicultural backgrounds CHOISES Young Women's Co-op members have to offer.

Level 1 water restrictions are now in place

More than 85% of Greater Sydney's water supply relies on rain. This means that our water is in short supply during prolonged droughts.

Water restrictions limit how and when we use **drinking water 3** outdoors and help reduce demand when we're not getting enough rain.

Water restrictions apply to everyone in Sydney, the Blue Mountains and the Illawarra. This includes both residents and businesses.

If we all do our bit and save a little, it will make a big difference across Greater Sydney.

What's allowed under Level 1 water restrictions?

What can't you do? What can you do? Watering lawns & gardens You can: You can't: water lawns and gardens use standard sprinklers with a watering can or and watering systems at bucket any time water lawns and gardens leave hoses and taps running unattended by hand held hose before 10 am or after 4 pm, as long as your hose is fitted with a trigger nozzle ? water your garden with drip irrigation systems water lawns and gardens with watering systems with one or more of these features: automated weather adjustment rain sensor soil moisture sensor water new turf for one week after it's delivered as long as you follow the instructions provided by the turf supplier
