Croydon development opens

The Croydon property of the Dunroamin Housing Co-operative opened on Thursday 11 March 2021. The new property is on Wangal Country of the Eora Nation. Dunroamin now operates over three properties: Croydon, Gladesville and Haberfield.





Brendan Kerin from the Metropolitan Local Aboriginal Land Council opened the proceedings with a smoking ceremony and an acknowledgement of country. In opening this way, we pay respect to the unceded land on which the property dwells and acknowledge and pay respects to the ancestors and elders of this country. Brendan also shared his personal story with us. Part of the ceremony included some of the ashes being collected into a jar (where ashes from other smoking ceremonies will be added) while some of the ashes remained on the property.

A marquee tent and chairs were set up in the backyard of the property with speeches on the back porch, which was already decorated in the greenery and plants of one of the new tenants. The marquee on the grass was filled with guests from the



Proceedings continued with speeches from the Minister for Families, Communities and

Disability Services, Common Equity's CEO, Nick Sabel and Carmen Osborne, CENSW Chair.

Later, light refreshments were served from the kitchen/lounge out the back of the house in true Covid-style - in individual cardboard boxes.

The event was a culmination of years of effort by CENSW and Dunroamin Co-operative. Current directors are grateful to former directors' efforts over the past few years to get us to this point. The development brought together several contemporary best practice ideas: deliberative design, adaptive reuse, co-living principles and infill affordable housing. The result is an innovative dwelling which includes two adaptable units. The building is also responsive to the Co-op's co-living needs while maintaining the building's original heritage character as well as supporting diversity.



Common Equity NSW Forum

The morning Assembly plenary session was extremely interesting. Ronni Kahn (founder of Oz Harvest) spoke about her journey in forming the well-known food rescue organisation and how it has changed its model somewhat in recent times. A quote she used resonated, particularly post COVID "Community is the new immunity" and I believe would resonate with our members too.

Assistant Professor Nathan Schneider Zoomed in from the University of Colorado Boulder in the USA. He provided a history of Co-ops in the U.S with a focus on his area (Boulder Colorado) and highlighted the fact that Co-ops have gone from a lateral to vertical structure, meaning they have become more hierarchical and focused on what they can do for the 'customer', moving away from the ethos of supporting members to 'do' and problem solve for and amongst themselves. He also mourned the loss of Co-op stories being told and discussed a range of online engagement platforms such as Lumio and Slack.

The CENSW Forum ran from 11am to 3.30pm – the purpose of the session was to help shape joint activity and support between Housing

Co-operatives and Common Equity and to explore potential opportunities to further develop the sector.

As per our last Forum, the issues were dissected within small groups and after lunch associated Action Items were developed by each group. These Action Items were then voted upon and will form the basis of a new Forum Action Plan which will be shared with you soon.

We gave participants the opportunity to provide feedback on our Strategic Plan and only received a few comments so we think we're on the right track!



Articulating the Value of Housing Co-operatives

WESTERN SYDNEY UNIVERSITY

In Australia we are facing a housing crisis. More and more households are struggling in insecure and unaffordable housing. As we know, Housing Co-operatives offer a great alternative.

This study will develop an evidence base about the benefits of the Australian affordable rental Housing Co-operative sector. It will identify the benefits of these Housing Co-operatives to co-op members and the broader community as well as calculate the cost effectiveness of delivering these benefits. The research will focus on co-operatives that are part of Common Equity NSW (CENSW), Common Equity Housing South Australia (CEHSA), Common Equity Housing Limited (CEHL Vic) and United Housing Co-operative both in Victoria, as well as Co-operation Housing W.A. The overarching national body that represents these organisations

and that commissioned the research is the Australian Co-operative Housing Alliance (ACHA).

The research will help to demonstrate the diversity of the sector across Australia. The project aimsto create an evidence base of what works in co-operative housing and challenges currently being faced, to help the sector and policy makers make decisions about how the sector might grow.

PROPERTY WORKS PROGRAMS

DPIE & LAHC funded projects

The first half of this year has certainly seen a lot of activity and upgrades happening across our portfolio. Despite the impact of COVID-19 and the extra challenges this threw at us all, we delivered all expected works within the required timeframes for both projects.

As reported previously Commo Equity was successful in receiving funding from the Department of Planning, Infrastructure & Environment (DPIE) for the Sustainable Energy / Thermal Upgrades Project and from the Land and Housing Corporation (LAHC).

An audit of all our properties was undertaken by SPM Assets in 2020 and the information gathered provided the basis of which properties were eligible for the heat pump hot water units and the insulation and/or draft proofing, which was funded under the DPIE funds.

These works have included upgrading 60 ageing hot water units by installing the more efficient heat pump model and undertaking works to help insulate and draught proof some 35 of our ageing properties.

Although there was slight hesitancy from some co-o

members, the majority have been thrilled with the new works and upgrades.

Bob Cregan from BRANCH Co-op "The experience was very good; the installer was very competent and experienced. We are thrilled to get the heat humps."

The LAHC funding has enabled a program of works which have improved the quality, safety and comfort of homes with repairs to bathrooms, external brick repairs, fencing and retaining walls across 16 LAHC properties throughout NSW.

This funding has allowed us to address priority maintenance works across our portfolio as well as expediting capital works, maintenance and upgrades on assets owned by LAHC.

The works were distributed across regional and metropolitan areas and include LAHC



properties we manage which are over 30 years old. Properties where vulnerability of residents, or where there are significant health and well being gains in completing works, have also been included.

As per funding requirements, we worked with Small to Medium Enterprises (SME) and engaged business that align with our values as much as possible.

Feedback from the LAHC is especially pleasing:

"The performance of CHPs, delivering \$40m in stimulus funds in under six months is a clear indicator of the capability of the sector and its capacity to deliver more for social housing tenants in NSW.

This achievement on the part of the sector will strengthen the case for future opportunities."



Sedgwick Co-operative observing the age-old tradition of 'senakulo'

Jimmy and Myrma from Sedgwick Co-op organise the 'senakulo' every year for almost 30 years!

Senakulo is the Filipino term for the re-enactment of the life and resurrection of Jesus Christ as told according to the 14 stations of the cross. It was a group effort with other members of the Co-op and the broader community being involved in the re-enactment.

The re-enactment was done in a grass clearing that allowed for all 14 stations to be set up temporarily. While the crowd was scarce, compared to the numbers in previous years, Jimmy and Myrma said they were happy they were still able to observe the Lent despite the pandemic and have been volunteering to do it since 1993, when they first moved to Australia. "We've been doing this for almost 30 years," he said.





CCA Review progress report

Last year we commenced a review of our Company Co-operative Agreement (CCA) with the aim to improve it and make it fit for purpose.

We established a CCA
Working Group comprising of
Co-op members and CENSW
staff to undertake the review in
a collaborative and transparent
manner. Co-op members on the
group are Chris Ryan (Planet X
and CENSW Member Director),
Tara Morelos (Extended Family),
Gary Luke (Emoh Ruo), and Kim
Brydon (Palace Womens).

The CCA Working Group has met 7 times over the last financial year. Most of its focus has been spent on reviewing the company rent methodology. This was a big and complex piece of work and took longer than expected.

The result of this work was the development of a new company rent approach based on 60% of rental income together with a 5% surplus contribution to a new

sector 'building and growth' fund for those Co-ops with \$90K or more in reserves. We will monitor the implementation of this new company rent approach over the next few years to ensure it is sustainable, helps achieve our common goal of growth and works for all.

For the rest of this year the review will focus on other aspects of the CCA including CENSW and Co-op responsibilities and compliance obligations and processes. The Land and Housing Corporation (LAHC) have also recently revised their head lease agreements with Community Housing Providers (CHP's) for LAHC owned properties, including a new 20 year lease for Tier 1 CHP's. We need to look at these lease changes and see what impact

this might have on our CCA. We are also looking closely at the 20-year lease option and seeing whether it is beneficial for our sector. We are seeking pro bono legal advice to assist us in this process and to ensure that any changes in the LAHC lease agreements are correctly included in our CCA to ensure compliance.

The CCA Working Group will continue to meet monthly throughout 2021/22. Any recommendations arising out of the continued review will be brought to the sector for consultation. This is likely to occur in the first half of 2022.

I want to thank and acknowledge all Working Group members for their on-going assistance and thoughtful contributions to the CCA Review. I also want to thank the sector for supporting this further extension to the review. This is an important project and there is much work to do.

The CCA is the key document that frames the relationship between CENSW and Co-ops for the use and operation of government owned properties, so it is important that it reflects best practice, is contemporary and ensures compliance with government policy and regulations.
