



## APPLICATION FOR COMMUNITY HOUSING WITH CENSW

Common Equity NSW provides two different types of housing. The first being Co-operative properties which are homes that are leased to a housing co-operative under a Co-operative Partnership Agreement (CPA) where the Co-operative is the landlord and CENSW is the Registered Community Housing Provider. CENSW either owns or leases these properties from the NSW Government (Land & Housing Corporation).

Direct managed properties are dwellings that are rented to individuals with CENSW as the landlord. Tenants are required to be eligible for social housing and currently on the Housing Pathways Social Housing Register.
